

I am a licensed minister of the gospel of Jesus Christ. I recently provided pastoral care for a distraught parent of a 9 year old child who came home from SCHOOL with a PowerPoint telling the parent that the child is now transgender and has picked a new name and pronouns and that the parent must now follow. The child told the parent they must do this because they have the support of the school and the transgender community. In the PowerPoint presentation the child made it known the parent would have to [quote] ‘grieve the loss of their child, but LOL, I was never really that child anyway.’ [unquote] The transgender cult religion has killed the authentic identity of this child.

This unconstitutional bill before you will remove that parent’s inalienable rights to combat this LGBTQ jihad against their child. This bill would require the parent grieve the loss of their child and in the future recognize the child in a transgender identity they know their child is not. This is religious tyranny and an attack on rights of parents of the most wicked kind.

You then told me of the testimonies from the LGBTQ community you heard and tried to convince me I was wrong.

In conclusion, here's the problem Representative Bierman, and take note everyone else. There is an unconstitutional religious jihad going on by the LGBTQ lobby. They are pushing lies and what THEY KNOW, and YOU KNOW, are unconstitutional laws or rules across the country.
